




5. May 2023, **Dr Yaacov Falkov** returned to Oxford for a second visit to support continuing collaboration with Professor Zoe Waxmann and Professor Andrei Zorin. He delivered two talks: one at the OCHJS about the Soviet secret service (NKVD) and its attitude to the Polish-Jewish refugees from the Nazioccupied territories of Poland, in 1939-1941; and the second, for the Faculty of Medieval and Modern Languages at the Taylor Institute, was dedicated to the roots of the self-perception of Russia as a besieged fortress and its influence on the Russian strategic culture. Besides, he continued his research at the National Archives (this time, new materials were found about the Holocaust motive in the inter-cellar conversations of German prisoners of war in British POW prisons). The latter subject is already being presented by him to Israeli and foreign colleagues, and there is a talk about turning it into a documentary

Research trips to Israel

Professor Nir Vulkan travelled to Israel to advise on an MA thesis, which he co-supervises. The subjects of the research are Arkia and Isra-Air airlines, and the topic of investigation is 'post purchase regret'. They hope the data will be the basis for a number of papers, extending far beyond this student's thesis. In parallel, Vulkan will undertake with this student and Professor Zvika Neeman, a senior economist at Tel Aviv University, a new theoretical paper, modelling the difference between 'positive' and 'negative' regret in economics (i.e. regretting over paying for experiences you did, versus regretting missing out on experiences because you were not willing to pay enough at the time).

The selection process was undertaken September-April 2022-23, conducted by the Massada Committee comprising David Isaac (the Provost), Professor Tsilly Dagan (Law), and Dr Naomi Rokotnitz (Programme Director), in collaboration with the other three legal scholars at Worcester – Professors Donal Nolan, Leah Trueblood, and James Edwards – and three senior legal scholars from abroad, who provided expert reader reviews of the written work of the three finalists.

Interviews were held in April and the committee unanimously voted to appoint Dr Neli Frost. A full report of the procedure and the recommendation to appoint Dr Frost was compiled by the Director of the programme, submitted to and approved by Worcester Governing Body in May 2023.

All related administration was coordinated by HR and the Programme Director, so she could commence her fellowship in September 2023.
